Report

- 01-03-08 3:40 pm Officer arrested a 21 year old Des Moines man for driving under suspension. He was cited and released with a court date.
- 01-07-08 2:00 am Officer responded to a fire at an abandoned trailer. He assisted fire until the fire was put out.
- 01-07-08 7:20 am Officer took a call from a Huxley resident about someone slashing two of his tires on his car sometime over the night. Unknown suspects.
- 01-08-08 6:43 pm Officer took a call of a minor traffic accident that took place in the BHS parking lot. A school bus and a BHS student's vehicle had a minor collision in front of the athletic doors. Neither party wanted a report made and no citations.
- 01-10-08 1:00 pm Officer arrested a 24 year old Des Moines man for driving while barred. Taken to jail.
- 01-11-08 8:40 am Officer took a call of a reckless driver northbound on I35. The officer finally got the vehicle to pull over a couple of miles north of the Hwy 210 exit. The elderly female complained of not feeling well and 1st responders and the ambulance was dispatched. She was taken to the hospital.
- 01-12-08 1:01 am Officer arrested a 34 year old Huxley man for OWI 1st. Subject taken to jail.
- 01-14-08 1:15 pm Officer was called to a residence that was owned and rented out by a Huxley couple. The couple stated the people that had been renting it had moved out and left a mess. Officer looked at the residence and found no major damage but something the owners could go after the renters in a civil case. Nothing further.
- 01-16-08 12:10 pm Officer was called to the Ballard West Elementary for an assault case. A 6 year old was assaulting the teacher and principal of the school. His parents were called and he was turned over to them and taken for help.
- 01-17-08 8:34 am Officer was called to the Fjeldburg church for a reported burglary. After the investigation, someone had broke into the church sometime after 10:20 pm and this morning when they arrived at work. There was damage to the doors and file cabinets that were pried open and also about \$100 in cash and a check. Under investigation.

- 01-17-08 3:30 pm Officer covered a two vehicle accident at Hwy 69 and E 4th. A 16 year old Ballard male struck a vehicle owned by a Huxley resident as it was driving north on Hwy 69. Approximately \$1200 damage. No citations.
- 01-20-08 2:00 pm Officers were called to a possible burglary of an apartment. The door to the apartment appeared to have been kicked in with little damage. Inside the apartment, everything appeared to be o.k. The officers did find a small amount of marijuana and a marijuana pipe. The renters of the apartment denied owning the narcotics. Also one of the renters stated that he had \$825 in cash in an unlocked safe that was found in the closet. No suspects and nothing else taken.
- 01-23-08 8:44 am Officer was called to an apartment to a burglary report. After the investigation, it was learned that the female caller was moving out of the apartment and had not been there the night before. Some property was taken such as a t.v., computer and jewelry. Under investigation.

- 01-25-08 4:24 pm Officer stopped a vehicle on Hwy 69 and arrested the 38 year old Ames man for possession of methamphetamine and paraphernalia. He was also arrested for OWI 1st offense for being under the influence of a narcotic while driving.
- 01-26-08 3:00 pm Officer arrested a 41 year old Huxley man on a warrant out of Story Co. Taken to jail.
- 01-27-08 6:00 pm Officer took a call from a Polk City female stating that her German Shepherd puppy was stolen from her residence in Huxley while she was moving to Polk City. After the investigation, it was determined that the dog probably ran away.
- 01-31-08 4:26 pm Officer arrested a 47 year old Nevada man for driving under suspension. He was cited and released with a court date.
- 01-31-08 6:30 pm Officer investigated a two vehicle accident that happened in a business parking lot. Under \$1,000 damage, report made and no citations.

For the month of January, Huxley Officers had 8 arrests. There were 2 for OWI, 2 for DUS, 1 DWB, 1 for Narcotics, 1 for paraphernalia and 1 warrant. Officers issued 30 citations for the month and gave 79 warnings. Officers had 20 assists for Fire, Ambulance or other agency and also 21 calls for assisting motorists. Officers had 132 calls for information or other assistance and a total of 364 contacts. Officers had 306.75 hours of answering calls, giving assistance or investigations / office time. Officers had 494.25 hours of patrol.
