Report

- 11-01-07 1:40 pm Officer investigated a 2 vehicle accident at the intersection of Oak Blvd and Timberlane. An Ames female failed to stop at the stop sign and struck a Brighton, Iowa mans vehicle. Approximately \$4,000 total damage. The Ames female was cited for failure to stop.
- 11-02-07 10:15 am School Officer had to remove a Jr High student who was being very disruptive in the class room and who was also threatening the teacher with physical harm. He was taken to the police department where his parents picked him up and placed on a 3 day school suspension. No charges.
- 11-02-07 5:08 pm Officer arrested a 27 year old Huxley man for possession of marijuana and paraphernalia. He was taken to jail.
- 11-03-07 10:13 pm Officer took a report of possible vandalism to a vehicle and a theft from the vehicle. A female Huxley resident thinks someone stole a pack of cigarettes from the vehicle and loosened the radiator hose in her engine compartment. No suspects.
- 11-05-07 10:29 am Officer took a report of a vehicle being hit in the BHS parking lot. About \$600 damage was done to the drivers side rear door of the BHS teachers vehicle. It is unknown when this happened for sure. No suspect vehicles.
- 11-05-07 1:39 pm Officer investigated the unattended death of a 71 year old male Huxley resident. Death was due to Natural Causes. Family was contacted.
- 11-06-07 4:52 pm Officer arrest a 53 year old Ankeny man for illegal possession of a prescription drug after finding it in his vehicle on a traffic stop. He was also cited for driving under suspension. Taken to jail.
- 11-08-07 12:30 pm Officer took a report from a Huxley boy about someone stealing his bike. It is a silver, black and yellow Mongoose 21 speed. About a \$200 loss.
- 11-09-07 1:30 pm Officer took a report from a male Huxley resident about 3 males coming to his apartment and kicking in the door and assaulting him. Stated that they took \$45 from him. No real good description was given of the males and no names were given. Report made.
- 11-11-07 1:19 am Officer arrested a 51 year old Huxley man for Indecent Exposure, Trespass and Disorderly Conduct. This all occurred because he was standing outside someone else's residence with just a white T shirt on. Taken to jail.
- 11-12-07 4:29 pm Officer was called about a 2 vehicle accident that happened the day before. A male Huxley resident stated that the day before, another male Huxley resident had struck his work truck while parked on the street. The two males exchanged information without calling the Police. No report made.

- 11-13-07 4:47 am Officer took a report from a male Huxley resident about someone slashing a tire on one of his vehicles and loosening the lug nuts on the one he drove to work. The male gave a name of an Indianola resident that may have done this because of prior problems with him. Under investigation.
- 11-13-07 3:56 pm Officer arrested a 36 year old Knoxville, Iowa man for driving under suspension. He was cited and released with a court date.
- 11-16-07 4:49 am Officer responded to a call of a burglary at an apartment. He met with the young couple who stated someone kicked in their door and asked for the male half. While dialing 911, the intruder left. No information about who may have done it was given. Under investigation.
- 11-15-07 2:20 pm Officer took a report from a 9th grader about his cell phone being stolen from his pants pocket while being left unattended in the gym locker room. Report made.
- 11-16-07 5:15 pm Officer took a report at the Huxley car wash about the automatic arm in the touch less car wash bay falling off the tracks and onto the hood of the vehicle in there. Unknown amount of damage.
- 11-19-07 10:00 pm Officer took a call about an ex wife violating a protection order on her ex husband. Documentation was made and a report filed with the Co Atty office.
- 11-20-07 12:40 pm School Officer was checking on a report of two kids that had skipped school and possible in an abandoned trailer in the trailer park. The two kids were found and ran on the officer. The officer was able to catch one of them and place him in custody and brought back to the office. Around 3:00 pm, the other student was found about 6 miles south of town walking through a bean field, covered in mud and very, very wet and cold. He was also taken into custody and brought back to the office. Both boys were charged with truancy, burglary, criminal mischief and referred to Juvenile Court. Both boys were also taken to a juvenile detention center.
- 11-21-07 8:30 am Officer received a report of possible sexual abuse. Under investigation.
- 11-21-07 6:00 pm Officers took a report from a female Huxley resident about being harassed by another female Huxley resident. Both parties were spoken to and told no more or charges could be filed.
- 11-23-07 11:34 pm Officer took a report from a female Huxley resident who was moving out of town. She stated that while moving stuff from her apartment to her vehicle, someone had stolen her purse from the vehicle. Report was made. Several days later, some of her items were located in a trash can in Ankeny. No suspects.

- 11-24-07 11:00 am Officer took a report of a 2 vehicle accident at E 4th and Hwy 69. A vehicle was stopped waiting to turn into a business drive and was struck from behind. No charges. Less than \$500 total damage.
- 11-24-07 8:45 pm Officer arrested a 41 year old Huxley man for OWI 1st. Taken to jail.
- 11-26-07 7:32 am Officer took a report from a male Huxley man about someone hitting the drivers side door on his vehicle while it was parked in the parking lot over the weekend. Unknown who struck the vehicle and about \$600 damage.
- 11-28-07 10:15 am Officer took a report from a male Huxley resident about someone scratching his vehicle some time over the night. Several scratches were located on the drivers side door. Report made.
- 11-28-07 8:45 am Officer arrested a 40 year old Johnston man for driving under suspension. Cited and released with a court date.
- 11-28-07 2:30 pm Officer responded to a call about smoke coming from an apartment. The officer, after he made sure it was safe, kicked in the door the smoke was coming from and found a pan that was burning on the stove and the 25 year old man who lived there, passed out on the couch. No injuries and only smoke damage.
- 11-30-07 11:30 am Officer arrested a 38 year old Pella female for driving under suspension and also a warrant out of Story Co. Taken to jail.
- 11-30-07 7:11 am Officer responded along with Huxley and Cambridge Fire to a house fire on Lynwood. The wood burning stove in the basement was the cause. Damage was contained to the carpet and some ceiling. No one injured.

Huxley Officers made 17 arrests and filed 19 charges for the month. The charges are broken down as follows: 4 for driving under suspension, 2 for truancy, 2 burglary, 2 criminal mischief, 1 OWI, 1 for marijuana possession, 1 for possession of paraphernalia, 1 for illegal possession of prescription drugs, 1 for indecent exposure, 1 trespass, 1 disorderly conduct, 1 violation of a protective order and 1 warrant served.

Officers issued 41 traffic citations and gave 80 warnings. Officers had 164 calls for information or service and a total of 463 contacts. Officers had 8 hours of on call, 294.5 hours of answering calls or giving assistance, 9.75 hours of investigations and 422.75 hours of patrol.
