- 06-01-07 3:30 pm Officer took a report from an elderly female Huxley resident about getting harassing phone calls coming from teenagers. Nothing was ever said but the calls were coming day and night and numerous times. Cell phone records were subpoenaed and under investigation.
- 06-02-07 5:45 am Officer took a report about a vehicle window that was busted out during the evening. According to the owner, nothing was taken from the vehicle and no suspects.
- 06-04-07 10:07 pm Officer found a 17 year old female in possession of alcohol behind the Casey's store. She was cited and released to her mother.
- 06-05-07 12:00 pm Officer took a report of harassment from a Huxley female. Reportedly, her father, who lives in Arizona, made threats of physical harm to her and her boyfriend if she kept up the fight for custody for her children from her parents.

- 06-26-07 6:07 pm Officer arrested a 19 year old Huxley man for driving under suspension. Cited and released with a court date.
- 06-27-07 4:24 am Officer arrested a 18 year old Slater male for possession of paraphernalia after he was called in as a suspicious person around the school. Cited and released.
- 06-27-07 11:12 pm Officer arrested a 31 year old Huxley man for OWI 1st. Taken to jail.
- 06-30-07 2:39 am Officer arrested a 24 year old Chatfield, MN man for OWI 1st offense. Taken to jail.
- 06-30-07 7:07 pm Officer was called to a residence in a apartment complex for a female who was threatening suicide. After speaking with the female, who admitted to thoughts of harming herself and attempting to cut herself, the officer transported her to MGMC to receive treatment.

Huxley Officers made 19 arrests for the month. 3 OWI, 3 for narcotic violations, 5 driving under suspension, 2 for interference, 3 for assault, 1 domestic abuse, 1 false imprisonment, 1 warrant and 1 possession of alcohol. Officers also assisted Ankeny and Ames PD with two felony arrests. Officers issued 56 traffic citations and gave 88 warnings for various violations.

Officers had 208 calls for information or assistance and a total of 583 contacts for the month. Officers had 246.75 hours of answering calls, 345.75 hours of patrol and 24 hours of investigations or on call.

Officers also delt with some solid waste violations and saw that some that notices that were sent out on were taken care of. Officers also sent out numerous letters to property owners about the weed / grass nuisance ordinance to have owners comply with the maximum 10" length.
