- 03-04-07 9:31am Officer took a report of theft from a Huxley female that was preparing to move out of state. After the report was taken, the female called the officer back and stated that most of her property had been returned and wished that nothing further be done.

Huxley Officers made 12 arrests for the month. 1 for obstruction of emergency phone call, 1 for domestic assault, 1 for OWI 1<sup>st</sup>, 1 for possession of marijuana, 1 for possession of paraphernalia, 1 for driving while barred, 1 for driving while revoked and 5 for driving while suspended. Officers had 368 calls for information and had a total of 714 contacts for the month. Officers issued 57 citations for traffic offenses and gave 114 warnings for the same. Officers had 352 hours of answering calls or giving assistance, 510 hours of patrol and 22 hours of taking call or investigations.
