- 05-02-07 7:55 pm Officer arrested a 32 year old Huxley man for driving under suspension. Two different charges. Cited and released him with a court date.

- 05-07-07 1:00 pm Officer arrested a 18 year old Des Moines boy for warrants out of Polk and Dallas Co.

The vehicle owner was unwilling to have charges filed and the suspect stated he would pay for the damages.

Huxley Officers made 23 arrests for the month. 9 for driving under suspension, 2 for assault, 2 OWI, 2 criminal mischief, 2 trespass, 2 drug or narcotic violation, 1 alcohol violation, 1 theft and 10 warrants were served. 55 citations were issued and 134 warnings given for traffic violations. 191 calls for information or assistance were taken and 563 total contacts were made. Officers had 337.25 hours of answering calls, 430.75 hours of patrol and 34.75 hours of investigations or call. Huxley officers have also been speaking with residents and or business owners about solid waste or nuisance violations. 2 fourteen day abatement notices have been served and one has complied to date.
