Report

- 10-02-07 2:00 pm Officer investigated a report of a burglary at a residence in Huxley Regency. After the investigation, a 11 year old Huxley female was arrested and charged with Burglary 3<sup>rd</sup> and Theft 5<sup>th</sup>. She was referred to Juvenile Court.
- 10-04-07 5:15 pm Office investigated a 2 vehicle accident on Hwy 69 at E 3<sup>rd</sup>. A vehicle was stopped because of traffic and another vehicle struck the rear end of her vehicle. About \$600 total damage to both vehicles. The 25 year old Boone female that caused the accident was cited for no insurance.
- 10-04-07 9:30 pm Officer took a report from some high school boys about their vehicles being hit by toilet paper and gravel. Officer found 4 freshman boys that were responsible for the act. No damage was done to either vehicle and the 4 boys were sent on their way.
- 10-05-07 5:30 pm Officer arrested a 33 year old Des Moines man for driving under suspension. He was cited and released with a court date.
- 10-05-07 10:13 pm Office was called by a Huxley female about her 16 year old nephew that has possible ran away from her residence. A few phone calls were made to friends and the 16 year old was found at another residence in town. He was taken back to his Aunt.
- 10-05-07 10:38 pm Officer was called about a person with a knife. After the investigation, a 62 year old Minneapolis, MN man was arrested for Aggravated Assault. He was here in town visiting family and staying in his motor home and thought a group of teens, out for homecoming, were going to do something to his trailer. He grabbed a large knife and chased them and made threats of harm to them.

- 10-06-07 11:02 pm Officer arrested a 48 year old Ames man for driving under suspension. He was also in possession of stolen property, the license plates on the vehicle he was driving. He was taken to jail.

The boyfriend was not located at the time of the call but was found the next day and charged with Domestic Assault and taken to jail.
- 10-15-07 3:15 pm Officer was called to a two vehicle accident at the intersection of Lynwood and N Main Ave. A 16 year old Huxley male failed to yield and turned in front of a northbound vehicle being driven by a 18 year old Cambridge female and both vehicles collided. Approximately \$6,000 total damage. The Huxley male was cited for the failure to yield.
- 10-16-07 10:15 am Officer took a report of a found bike. The newer "retro" style Schwinn 1 speed bike painted blue with chrome fenders and a front basket was found near a business on S Main. The bike was taken into possession for an owner to claim.
- 10-16-07 5:00 pm Officer took a report from a High School student about someone stealing his bike. On 10-22-07 the bike was found unharmed and returned to the owner.
- 10-16-07 11:01 pm Officer arrested a 20 year old Ankeny man for OWI 1<sup>st</sup>. He was taken to jail.
- 10-17-07 12:50 pm Officer was called by a citizen on Parkridge about finding a young boy, about 2 years old, walking down the middle of the street with no adults in sight. Upon further investigation, the child lived across the street in Park Place apartments. The babysitter had put the child down for a nap and fell asleep herself and the child was able to get out of the apartment. The child was unharmed and the babysitter spoken to about the incident. The mother of the child was also contacted about the incident.

- 10-17-07 4:34 pm Officer arrested a 21 year old Cambridge female for driving under suspension. She was cited and released with a court date.
- 10-17-07 11:52 pm Officers were called to a residence on E 5<sup>th</sup> about a possible assault. The female in the residence had a large bump to the forehead and claimed she tripped over her housedog and struck the floor. The husband stated the same thing had happened. There was no other evidence that officers could find to say a domestic had taken place. Report made and no charges.
- 10-19-07 12:00 pm Officer was called by a Huxley business about a bad check they had received. After the officer made contact with the rural Huxley resident about the check, the payment was made in full. No charges.
- 10-19-07 6:50 pm Officer took a call of a hit and run accident at a Huxley business. The officer met with the Roland female whose vehicle had been ran into. There was approximately \$100 damage done to the vehicle. The only information about the other vehicle was that it was a car and a female driving it. No other information obtained.
- 10-20-07 7:02 am Officer took a report of a vehicle that had been broken into over the night time while it sat in the BHS parking lot. Approximately \$600 in property taken from the vehicle and \$250 damage to the window. Unknown suspects.
- 10-20-07 2:20 pm Officers investigated a 2 vehicle injury accident at the intersection of Hwy 69 and Oak / Main. A 70 year old Huxley man pulled out in front of a northbound vehicle driven by a Johnston female. The Johnston female struck the front right quarter of the Huxley man's vehicle. A passenger in the Johnston females vehicle was transported to Mary Greeley for possible injuries as well as the Huxley man. The Huxley man was cited for failing to yield while entering the highway.
- 10-20-07 10:52 pm Officer arrested a 19 year old Ames male for OWI 1<sup>st</sup>. He was taken to jail.
- 10-21-07 1:49 am Officer arrested a 22 year old Corning male for OWI 1<sup>st</sup>. He was taken to jail.
- 10-22-07 12:35 pm Officer was called to the 3C's building for a fire alarm going off. After the investigation, a 15 year old Cambridge boy was arrested and charged with False Report for pulling the fire alarm and Disorderly Conduct. He was referred to juvenile court and released to his mother.

- 10-23-07 6:45 pm Officer was called to an apartment about a suspicious odor. Upon arrival, the officer located the apartment where the odor was coming from. The female renter of the apartment opened the door and the officer spoke to the three persons in the apartment. After the investigation, the 19 year old female renter was arrested and charged with possession of marijuana and taken to jail. A 17 year old Slater male was also charged with possession of marijuana and referred to juvenile court and released to his parents.
- 10-26-07 10:35 am Officer investigated a 2 vehicle accident in the driveway of New Horizons. A 44 year old Boone man was backing out of the main driveway onto E 1<sup>st</sup> St and struck a vehicle being driven by a Ames woman. No damage done to the Boone man's truck and approximately \$400 to the Ames woman's car. No charges.
- 10-26-07 4:50 pm Officer took a report from a 7<sup>th</sup> grade students parent about his son's bike getting stolen. It is a Schwinn Mirada RSTOMNI 26" silver and black boys bike.
- 10-26-07 10:55 pm Officer took a report of a gas drive off from Casey's where the suspect actually left his wallet laying on the counter. The 23 year old Ames man was contacted and came back and paid for the gas. No charges.
- 10-28-07 2:10 am Officer was called to Oak View apartments in reference to a fight that had occurred. After the investigation was over a 22 year old Huxley man was arrested and charged with assault, interference with official acts and harassment of a public official. He was taken to jail.

Huxley Officers had 26 arrests for the month and they are as follows: 6 for OWI, 6 for driving under suspension, 2 for possession of marijuana, 2 for possession of paraphernalia, 1 for harassment, 1 for interference, 1 for simple assault, 1 for disorderly conduct, 1 for false report, 1 for domestic assault, 1 for aggravated assault, 1 for possession of stolen property, 1 for burglary and 1 for theft 5<sup>th</sup>.

Huxley Officers issued 45 traffic citations and gave 105 warnings for the same. Officers had 162 calls for information or assistance and a total of 539 contacts for the month. Officers had 309.75 hours for investigations, answering calls or giving assistance and 465.75 hours of patrol.
