- 09-03-07 5:03 am Officer arrested a 35 year old Huxley female for driving under suspension. Cited and released her with a court date.
- 09-05-07 9:30 am Officer investigated a report of theft from a Huxley business. Two employees committed the theft. After the investigation, a 29 year old Huxley female and a 26 year old Slater female were arrested and charged with theft 5th. Both were cited and released with a court date.

Huxley Officers made 19 arrests for the month of September. 6 for driving under suspension, 5 for OWI, 2 for theft, 2 for Tobacco violations, 1 for possession of alcohol under the legal age, 1 for a false report, 1 for harassment and 1 warrant served. Officers issued 79 citations for traffic violations and gave 164 warnings for other traffic violations. Officers had 149 calls for assistance or information and had a total of 576 contacts for the month.

Officers had 299 hours of answering of calls or assisting the public and 479.25 hours of patrol.
